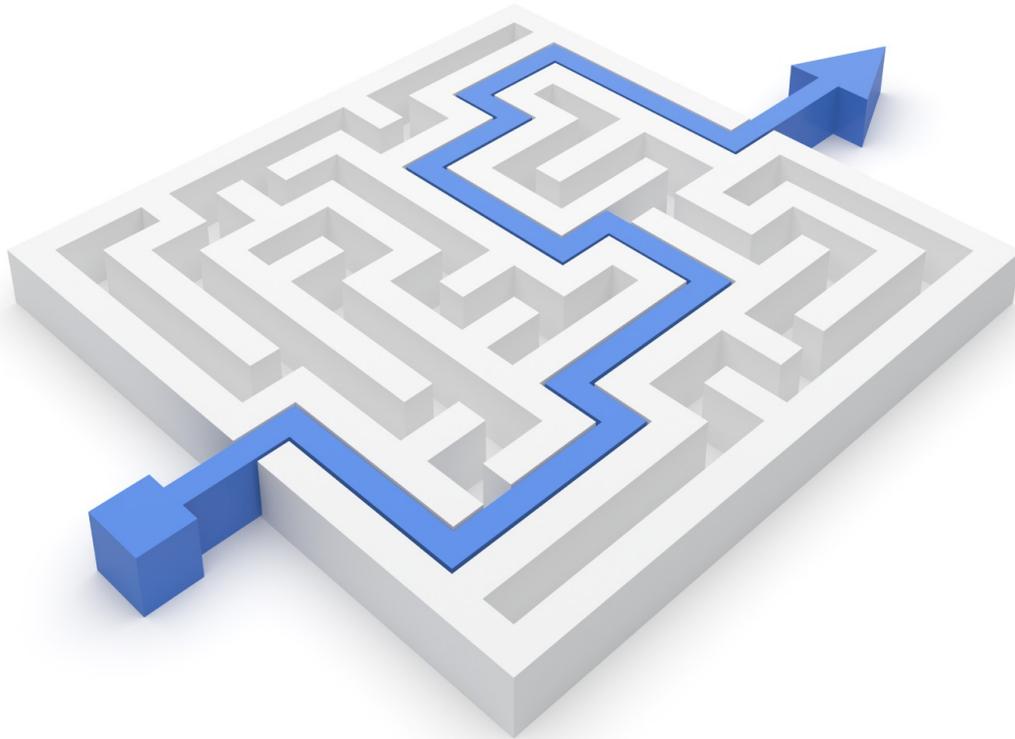

This process involves making sure the responding entity is the proper source and not a fraudulent third party.

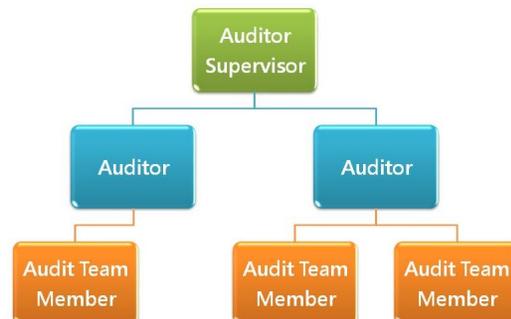
Reporting and Data Retention

Registration and Validation

Validating participants is critical to controlling the audit confirmation process. Confirmation.com validates the requestor and all In-Network responders using a proprietary Authenticity and Authorization process. A Client Authorization Code (AUD) is required to transmit the request, and acts as the client's digital signature providing the responder with assurance regarding the release of client data.

Manager Review Functionality

Many responding organizations require a manager or supervisor to review confirmation responses before they are returned to the auditor (requestor). Confirmation.com allows bank supervisors the flexibility of reviewing some or all of the responses.

Pre-Processing

This feature helps balance confirmation volumes during peak season by allowing you to view and queue certain responses for Future Dated confirmations in advance of their request date.

Advanced Search Capability

Management Reporting

- **Future Dated** - Shows you the future dated volume in advance of peak periods.

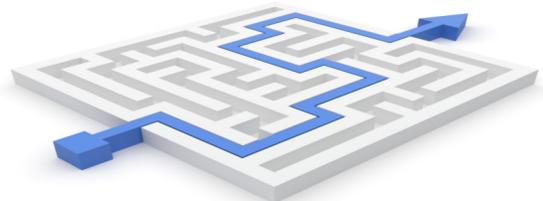

Account Maintenance
