
**AFFIDAVIT OF MARSHA L. GREEN, CLAIMANT (CLAIM #26) IN SUPPORT OF
RESPONSE TO FACTUAL ISSUES IN THE EQUITY RECEIVER'S OBJECTION**

Marsha L. Green first being duly sworn, states as follows:

1. I have personal knowledge of the contents of this affidavit and I am competent to testify as to them.
2. In 1999, I was encouraged to invest in an entity called Kaivalya Holding Group, Inc. (hereinafter "Kaivalya") by the Defendant, Robert W. Shimer.
3. I invested \$134,600.00 under the terms of a Promissory Note, which provided for repayment of my principle.
4. To date, I have not received any interest on the principle invested in Kaivalya.

5. On October 31, 2003, invested in Shasta Capital Associates, LLC. (hereinafter "Shasta") once again through, Defendant, Robert W. Shimer, by wiring \$50,000.00 of my retirement funds to Shasta pursuant to the Subscription Agreement of October 28, 2003.
6. On February 6, 2004, I invested an additional \$15,000.00 into Shasta via First Union Check Number 1275.
7. Kaivalya sent to me Patriot Bank Check Number 655 in the amount of \$40,000.00 on February 6, 2004, which was represented to me as a portion of the return of my principal investment with Kaivalya.
8. I invested these same funds back into Shasta via a wire transfer on February 12, 2004 in the amount of \$40,000.00.
9. I made my last investment of \$47,000.00 via wire transfer to Shasta on April 2, 2004.
10. The total amount of funds I invested with Shasta was \$152,000.00.
11. I have reviewed the content of the Response To Legal Issues In The Equity Receiver's Objection and the Response To Factual Issues In The Equity Receiver's Objection filed by my Attorneys on my behalf and affirm the accuracy of the information contained therein.
