Re: Rule Certification. NYMEX Submission 04-49: Notification of an Approved Amendment to Supplement No. 1, "Official List of Approved Brands and Markings" of the Aluminum Futures Contract.

Dear CFTC Commissioners:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of an approved amendment to Supplement No. 1, "Official List of Approved Brands and Markings" of the Aluminum Futures Contract to be implemented effective Friday, April 23, 2004. The approved amendment changes the brand name of the aluminum T-bars produced by Alcoa-Aluminerie de Deschambault S.E.N.C from "LAURALCO" to "DESCHAMBAULT." The aluminum T-bars branded "LAURALCO" are in inventory at the Exchange Licensed Warehouses and will continue to remain acceptable for delivery against the Aluminum Futures Contract. The "LAURALCO" brand will be marked with an asterisk (*) indicating that the brand is no longer produced.

Exchange submission 04-30, dated March 5, 2004, notified the Commission of an approved amendment to Supplement No. 1, "Official List of Approved Brands and Markings" which changed the name of the producer from Aluminerie Lauralco Inc. to Alcoa-Aluminerie de Deschambault S.E.N.C.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. The approved amendment will go into effect on Friday, April 23, 2004.
