Pursuant to Commission Regulation 40.6(a), the Chicago Board of Trade (CBOT[®]) hereby submits the following:

- **Amendment to CBOT Rulebook Appendix 9B-3 per the attached text (additions bold and underlined).**

The referenced amendment will codify the e-cbot[®] “no-bust” ranges for CBOT Dow Jones Industrial AverageSM Index (\$25 Multiplier) Futures. (The Exchange’s “e-cbot Error Trade Policy” for electronic trading, as set forth in Rulebook Appendix 9B-2, incorporates, by reference, a “no-bust” range, as specified in Appendix 9B-3, for each electronically traded product.)

The CBOT intends to implement this amendment concurrently with the launch of trading in the referenced contract (scheduled for March 20, 2006).

There were no opposing views concerning this amendment.

The CBOT certifies that this amendment complies with the Commodity Exchange Act and the rules thereunder.
