
Pursuant to Section 5c(c) of the Commodity Exchange Act (the "Act") and Section 40.6(a) of the regulations of the Commodity Futures Trading Commission (the "Commission"), DW SEF LLC ("DW") hereby notifies the Commission that it hereby withdraws Rule 1005, as that Rule was proposed in the DW SEF Rulebook submitted on July 29, 2014. The Rule has been withdrawn at the request of CFTC staff. All other proposed Rule changes or revisions included in DW's Rulebook submitted on July 29, 2014, shall be effective on August 13, 2014, as scheduled.
