**FINAL DECISION**

The parties have unanimously elected to submit their dispute to resolution under the "Voluntary" decisional procedure set out in subpart C of the Commission's reparations rules. This election constitutes a waiver of the opportunity for an oral hearing, a waiver of the right to a decision with accompanying findings of fact, and a waiver of the right to appeal this final decision. See CFTC rules 12.100 and 12.106.

Accordingly, after a careful review of the documentary record, it has been concluded: that Lawrence Scott Spain and Brandon Financial Corporation, Incorporated violated CFTC rule 33.10(a) and Section 4c(b) of the Commodity Exchange Act; that Brandon Financial Corporation is liable for Spain's violations pursuant to Section 2(a)(1)(B) of the Commodity Exchange Act; that the violations during the term of the guarantee agreement between National Commodity Corporation, Incorporated and Brandon Financial caused \$1,636 in damages; that the violations during the term of the guarantee agreement between Rosenthal Collins Group, LLC and Brandon Financial


caused \$26,858 in damages; that the liability of National Commodity Corporation as guarantor is \$1,636; and that the liability of Rosenthal Collins Group as guarantor is \$26,858. Accordingly, separate and distinct awards have been entered as follows:

National Commodity Corporation, Incorporated, Brandon Financial Corporation, Incorporated, and Lawrence Scott Spain are ORDERED to pay to Frank Dittmer reparations of \$1,636. Liability for this \$1,636 award is joint and several.

Rosenthal Collins Group, LLC, Brandon Financial Corporation, Incorporated, and Lawrence Scott Spain are ORDERED to pay to Frank Dittmer reparations of \$26,858. Liability for this \$26,858 award is joint and several.

In addition, National Commodity Corporation, Incorporated, Rosenthal Collins Group, LLC, Brandon Financial Corporation, Incorporated, and Lawrence Scott Spain are ORDERED to pay to Frank Dittmer \$50 in costs for the filing fee. Liability for this \$50 award is joint and several.
