**RE: Weekly Notification of Rule Amendments: Nadex Adds Strikes in its Daily EUR/JPY, GBP/JPY, and USD/JPY Binary Contracts on Trade Date April 4, 2013 – Submission Pursuant to Commission Regulation §40.6(d)**

Dear Ms. Jurgens:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily EUR/JPY Binary Contracts with expiration times of 3PM, 7PM, and 11PM, in its Daily GBP/JPY Binary Contracts with expiration times of 3PM, 7PM, 11PM, 3AM, and 7AM, and in its Daily USD/JPY Binary Contracts with expiration times of 3PM, 7PM, and 11PM on trade date April 4, 2013 due to volatility in the underlying market on that day. Nadex returned to its regular listing schedule for these contracts on April 5, 2013.

New strikes created on trade date April 4, 2013 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
