Re: Rule Certification. Commodity Exchange, Inc. Submission# 11-143: Notification of Amendment to Supplement No. 1, "Official List of Approved Refiners and Brands" of the Exchange's Silver Futures Contract – Xstrata Canada Corporation

Dear Mr. Stawick:

The Commodity Exchange, Inc. ("COMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of that it is self-certifying an amendment to Supplement No. 1 "Official List of Refiners and Brands" of the Exchange's Silver futures contract to be implemented effective Monday, July 18, 2011. The amendment is intended to change the producer name for the silver brand "CCR Canada", which is acceptable for delivery against the Exchange's Silver futures contract, from Noranda Metallurgy, Inc. to Xstrata Canada Corporation.

Xstrata Canada Inc. is a Canadian corporation that exists under the laws of the Province of Ontario and a wholly-owned subsidiary of Swiss based Xstrata Plc which exists as a corporation under the laws of the United Kingdom. Xstrata has notified the Exchange that its silver brand under the producer name "Noranda Metallurgy Inc." currently deliverable against the Exchange's Silver futures contract, is to be listed under the producer name, "Xstrata Canada Corporation."

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached amendment to Supplement No. 1 complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal. This amendment will go into effect on Monday, July 18, 2011.
