**Re: Rule Amendment. New York Mercantile Exchange, Inc. Submission # 11-322:  
Notification Regarding Amendments to Transaction Fees for Eight (8) Metals  
Contracts Listed on NYMEX**

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to the transaction fees for eight (8) metals products listed on NYMEX in order to comply with Commodity Exchange, Inc. ("COMEX") Bylaws, Article I, Section 105 (the "COMEX Bylaw"). Specifically, the COMEX Bylaw requires that Cross Division member rates be "at least 50% lower than the respective fees charged to participants in the next highest tier of such fees and shall be the lowest tier with respect to such fees."

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rules 40.6, the Exchange hereby certifies that the attached fee amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to the proposal. The amended transactional fees will take effect on trade date September 6, 2011.
