If the CCX carbon trading platform performs a significant price discovery function, then it seems to me like all the over-the-counter voluntary carbon trading going on right now also serves the same function and should come under the authority of the CFTC.

The Climate Action Reserve (www.climateactionreserve.org), formerly the California Climate Action Registry, have had numerous over-the-counter voluntary carbon transactions so it seems they also serve a significant price discovery function.
