AFFIDAVIT OF STEPHEN T. BOBO IN SUPPORT OF MOTION FOR ORDER FIXING **ALLOWED AMOUNT OF NON-INVESTOR CREDITOR CLAIMS**

Stephen T. Bobo, first being duly sworn, states and answers as follows:

- I am an attorney licensed to practice in the State of Illinois and the District of 1. Columbia.
- I have personal knowledge of the contents of this affidavit and am competent to 2. testify regarding them.
- Since April 1, 2004, I have served initially as Temporary Equity Receiver and 3. thereafter as Equity Receiver for certain of the Defendants, including Tech Traders, Inc., Tech Traders, Ltd., and Equity Financial Group, LLC.
- On December 18, 2006, the Court entered an order authorizing and directing me to carry out a creditor claim process. In particular, the Court ordered me to distribute a creditor

claim form and an explanatory letter, attached hereto as Exhibit A, to all non-investor creditors of Tech Traders and Equity.

- As a result, on January 5, 2007, I caused to be mailed the creditor claim form and 5. accompanying letter to all potential non-investor creditors of Tech Traders and Equity. These non-investor creditors included former employees of Tech Traders and Equity and recipients of payments from Tech Traders and Equity during the period of January 1, 2002 through April 1, 2004, such as landlords, utilities, supply and service companies, and federal, state and local taxing authorities. These creditors were also identified from invoices and other requests for payment received by Tech Traders and Equity.
- In a number of instances, the mailings were returned to me because of incorrect contact information. With the assistance of my counsel, I attempted to locate new contact information for these potential creditors. When such contact information was located, I distributed the claim form and accompanying letter to these creditors.
- In response, I received proofs of claim from three non-investor creditors, including PSNC Energy, Laure D. Hadder, CPA, and Bette Oberecker. Based on the claim forms and supporting documentation submitted by these creditors, I propose the following treatment:
- PSNC Energy: PSNC Energy submitted a proof of claim against Tech Traders, Inc. for natural gas services provided to Tech Traders at its former place of business in Gastonia, North Carolina. Along with the completed claim form, PSNC produced an invoice showing that Tech Traders owes a total of \$102.98 for these services. A copy of the claim form and invoice are attached hereto as Exhibit B. I recommend that PSNC's claim be allowed in the amount of \$102.98 against Tech Traders, Inc.

- Laure D. Hadder, CPA: Ms. Hadder and her accounting firm, Laure D. Hadder, 9. CPA, submitted a proof of claim against Tech Traders for payroll and bookkeeping services provided to Tech Traders, Inc. between February 2004 and July 2004. In particular, the claim indicates that Ms. Hadder seeks \$260.00 for services rendered from February through April 2004 (the "May 2004 Invoice") and \$756.25 for services performed between May and July 2004 (the "July 2004 Invoice"). I do not take issue with most of the fees sought in the May 2004 Invoice. Of the total amount sought, \$243.75 relates to services performed prior to the Court's April 1, 2004 freeze order. Copies of the claim form and invoices are attached hereto as Exhibit C. I object to \$16.25 sought in the May 2004 Invoice, as well as the July 2004 Invoice in its entirety, because the services for which fees are sought were performed after the Court's April 1, 2004 freeze order. I therefore recommend that Ms. Hadder's claim be allowed in the amount of \$243.75 for the services her accounting firm performed prior to April 1, 2004.
- Bette Oberecker: Ms. Oberecker submitted a proof of claim against Equity and 10. Vincent J. Firth for an outstanding debt owed to her by Vincent and Patricia Firth. In particular, the claim indicates that this debt originated from the Firths' purchase of Ms. Oberecker's home in 1990. According to her claim form and supporting documentation, in 1992, Ms. Oberecker obtained a judgment note in the amount of \$67,500.00 against the Firths for this outstanding debt. A copy of the Oberecker claim form is attached hereto as Exhibit D. This real estate transaction between Ms. Oberecker and the Firths, however, does not relate in anyway to Equity or its dealings on behalf of Shasta with Tech Traders. Consequently, I recommend that Ms. Oberecker's claim be disallowed in full.
- These three non-investor creditors have been served with a notice regarding my 11. motion for an order fixing the amount of non-investor creditor claims, which is attached hereto as Exhibit E.

# AFFIDAVIT OF STEPHEN T. BOBO IN SUPPORT OF MOTION FOR ORDER FIXING ALLOWED AMOUNT OF NON-INVESTOR CREDITOR CLAIMS

Stephen T. Bobo, first being duly sworn, states and answers as follows:

- 1. I am an attorney licensed to practice in the State of Illinois and the District of Columbia.
- 2. I have personal knowledge of the contents of this affidavit and am competent to testify regarding them.
- 3. Since April 1, 2004, I have served initially as Temporary Equity Receiver and thereafter as Equity Receiver for certain of the Defendants, including Tech Traders, Inc., Tech Traders, Ltd., and Equity Financial Group, LLC.
- 4. On December 18, 2006, the Court entered an order authorizing and directing me to carry out a creditor claim process. In particular, the Court ordered me to distribute a creditor

claim form and an explanatory letter, attached hereto as Exhibit A, to all non-investor creditors of Tech Traders and Equity.

- As a result, on January 5, 2007, I caused to be mailed the creditor claim form and 5. accompanying letter to all potential non-investor creditors of Tech Traders and Equity. These non-investor creditors included former employees of Tech Traders and Equity and recipients of payments from Tech Traders and Equity during the period of January 1, 2002 through April 1, 2004, such as landlords, utilities, supply and service companies, and federal, state and local taxing authorities. These creditors were also identified from invoices and other requests for payment received by Tech Traders and Equity.
- In a number of instances, the mailings were returned to me because of incorrect 6. contact information. With the assistance of my counsel, I attempted to locate new contact information for these potential creditors. When such contact information was located, I distributed the claim form and accompanying letter to these creditors.
- In response, I received proofs of claim from three non-investor creditors, including PSNC Energy, Laure D. Hadder, CPA, and Bette Oberecker. Based on the claim forms and supporting documentation submitted by these creditors, I propose the following treatment:
- 8. PSNC Energy: PSNC Energy submitted a proof of claim against Tech Traders, Inc. for natural gas services provided to Tech Traders at its former place of business in Gastonia, North Carolina. Along with the completed claim form, PSNC produced an invoice showing that Tech Traders owes a total of \$102.98 for these services. A copy of the claim form and invoice are attached hereto as Exhibit B. I recommend that PSNC's claim be allowed in the amount of \$102.98 against Tech Traders, Inc.

- 9. Laure D. Hadder, CPA: Ms. Hadder and her accounting firm, Laure D. Hadder, CPA, submitted a proof of claim against Tech Traders for payroll and bookkeeping services provided to Tech Traders, Inc. between February 2004 and July 2004. In particular, the claim indicates that Ms. Hadder seeks \$260.00 for services rendered from February through April 2004 (the "May 2004 Invoice") and \$756.25 for services performed between May and July 2004 (the "July 2004 Invoice"). I do not take issue with most of the fees sought in the May 2004 Invoice. Of the total amount sought, \$243.75 relates to services performed prior to the Court's April 1, 2004 freeze order. Copies of the claim form and invoices are attached hereto as Exhibit C. I object to \$16.25 sought in the May 2004 Invoice, as well as the July 2004 Invoice in its entirety, because the services for which fees are sought were performed after the Court's April 1, 2004 freeze order. I therefore recommend that Ms. Hadder's claim be allowed in the amount of \$243.75 for the services her accounting firm performed prior to April 1, 2004.
- 10. Bette Oberecker: Ms. Oberecker submitted a proof of claim against Equity and Vincent J. Firth for an outstanding debt owed to her by Vincent and Patricia Firth. In particular, the claim indicates that this debt originated from the Firths' purchase of Ms. Oberecker's home in 1990. According to her claim form and supporting documentation, in 1992, Ms. Oberecker obtained a judgment note in the amount of \$67,500.00 against the Firths for this outstanding debt. A copy of the Oberecker claim form is attached hereto as Exhibit D. This real estate transaction between Ms. Oberecker and the Firths, however, does not relate in anyway to Equity or its dealings on behalf of Shasta with Tech Traders. Consequently, I recommend that Ms. Oberecker's claim be disallowed in full.
- 11. These three non-investor creditors have been served with a notice regarding my motion for an order fixing the amount of non-investor creditor claims, which is attached hereto as Exhibit E.
