Rule Amendment to the Last Trading Day for 30 Swaps Contracts Listed on

NYMEX ClearPortTM.

Dear CFTC Commissioners:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of a rule amendment to extend the Last Trading Day to the last business day of the contract month for thirty (30) swaps listed on NYMEX ClearPortTM. This change will become effective on Tuesday, March 27, 2007.

This rule amendment will apply to the following swaps contracts listed on NYMEX ClearPort® for both clearing and trading:
