The New York Mercantile Exchange ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of the delisting of the NYMEX No. 14 Sugar Futures Contract and NYMEX Orange Juice Futures Contract.

Effective the close of business Monday, June 11, 2007, NYMEX will delist and not make available for trading on CME Globex® or clearing in any capacity the NYMEX No. 14 Sugar Futures Contract ("FT"). Further, effective on the close of business Monday, June 11, 2007, NYMEX will delist NYMEX Orange Juice Futures Contract ("FJ") for trading on CME Globex® or clearing in any capacity all contract months with the exception of the July 2007 contract which will expire on June 29, 2007. Exchange Notice to Members No. 07-305 dated June 8, 2007, will be distributed after the close of the market on June 8, 2007 (attached).

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached notification complies with the Act, including regulations under the Act.
