Re: Rule Certification. NYMEX Submission 07-60: Notification of Approved Amendment to Supplement No. 1, "Official List of Approved Brands and Markings" of the Grade 1 Copper Futures Contract.

Dear CFTC Commissioners:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of an approved amendment to Supplement No. 1, "Official List of Approved Brands and Markings" of the Grade 1 Copper Futures Contract to be implemented effective Friday, June 15, 2007. The amendment delists the Pinto, BHP Copper, and BHP Copper/SXEW copper brands produced by Billitton Copper, Inc. from the "Official List of Approved Brands and Markings" of the Grade 1 Copper Futures Contract. This brand is bracketed to indicate that it has been deleted. As a note, the Exchange licensed warehouses have no copper cathodes bearing this brand in storage.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. This approved amendment will go into effect on Friday, June 15, 2007.
