### **Petition for Modification of Order of Designation**

On November 3, 2020, the Commodity Futures Trading Commission issued an Order of Designation ("Designation Order") to KalshiEx LLC (the "Exchange") as a Designated Contract Market ("DCM").

# The Requested Modification

The Designation Order limited the Exchange to operating solely using a non-intermediated trading model ("direct trading model"). The Exchange now requests that the Designation Order be amended to permit futures commission merchants to carry customer accounts.

The Exchange's business plan following designation as a contract market was to concentrate on offering Event Contracts that it would offer directly to Exchange Members utilizing a direct membership model. As the market in general and the Exchange have evolved, the Exchange's business plan is now to increase access to these products in a manner that will result in a more liquid market that will benefit all market participants.

Accordingly, the Exchange is petitioning the Commission to modify its Designation Order to remove the clause prohibiting Kalshi from permitting intermediation so that the Designation Order will read as follows (underscored text indicates additions, and overstruck text indicates deletions):

IT IS HEREBY ORDERED, pursuant to Sections 5 and 6(a) of the Act, that the application of Kalshi for designation as a contract market is approved, subject to the terms and conditions specified herein:

- (1) Kalshi shall comply with all representations and submissions made by Kalshi in support of its application for designation as a contract market, as shown in the application record; and
- (2) Kalshi shall comply with all provisions of the Act and all requirements set forth in the Commission's regulations, as may be amended or adopted from time to time, that are applicable to designated contract markets.; and
- (3) Kalshi may not permit any futures commission merchant to intermediate any transactions or carry accounts for customers executing trades on, or pursuant to the rules of, the contract market unless the Kalshi Order of Designation has been amended to permit futures commission merchants to carry customer accounts.

#### The Requested Modification is Appropriate and in the Public Interest

The modification of the Designation Order being requested will permit Kalshi to allow futures commission merchants ("FCMs") to carry customer accounts. This will provide a significant convenience to potential members who are familiar with a particular interface,

or have established relationships with an FCM.

Further, removing the prohibition on FCMs will allow the Exchange to compete with other exchanges who allow FCMs, further enhancing the competitive nature of trading which will both benefit market participants and also advance the CEA's goal of promoting fair competition.

#### Conclusion

Based upon above facts and analysis and the supporting documents incorporated herein, KalshiEx LLC Petitions the Commodity Futures Trading Commission to modify the Order of Designation of KalshiEx LLC, issued November 3, 2020, by amending the language as discussed above.
