New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") that it plans to extend the NYMEX Natural Gas Deferred Credit Incentive Program ("Program") through January 31, 2023. The extension of the Program will become effective on February 1, 2022. All other Program terms remain unchanged.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

NYMEX reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, Availability of General Information, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The incentives in the Program do not impact the Exchange's order execution. Participants in the Program will be selected by NYMEX staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with NYMEX in which each participant will expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

NYMEX certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

# **NYMEX Natural Gas Deferred Credit Incentive Program**

#### **Program Purpose**

The purpose of this Program is to incentivize participants to provide liquidity in the products listed below. The resulting additional central limit order book liquidity benefits all participants in the market.

#### **Product Scope**

Henry Hub Natural Gas Futures ("NG") and Natural Gas (Henry Hub) Last-Day Financial Futures ("HH") that are traded on the CME Globex Platform.

#### **Eligible Participants**

There is no limit to the number of participants that may participate in the Program. Participants must be classified as a bank or commercial firm as determined by the Exchange. Participants may be members or non-members.

### **Program Term**

Start date is July 1, 2018. End date is January 31, 2022 January 31, 2023.

### **Obligations**

Participants will receive predetermined incentives based on volume traded in the Products.

#### **Incentives**

Upon meeting all Program obligations, as determined by the Exchange, participants will be eligible to receive predetermined incentives.

## **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant has failed to meet the eligibility requirements or obligations of the Program.
