CONCISE EXPLANATION AND ANALYSIS OF THE OPERATION, PURPOSE, AND EFFECT OF THE PROPOSED RULE AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION’S REGULATIONS THEREUNDER

Eurex Clearing is amending the Price List to introduce transaction fees for OTC block trades in EURO STOXX 50® Index Options that have been electively not disclosed intraday by Eurex Deutschland and Eurex Zürich AG’s (collectively, the “Eurex Exchanges”) T7 system. A chart with the application transaction fees is provided in the attached Eurex Clearing Circular 018/18.

Further information regarding the operation, purpose, and effect of the proposed amendments is discussed in the attached Eurex Clearing Circular 018/18, which is appended as Attachment A.

Eurex Clearing has identified the following derivatives clearing organization (“DCO”) Core Principle as potentially being relevant to the above amendments:

1. DCO Core Principle C (Participant and Product Eligibility): The proposed amendments will comply with DCO Core Principle C because the amendments introduce new transaction fees for certain block trades, and all products listed on the Eurex Exchanges, and cleared by Eurex Clearing, will continue to be subject to appropriate standards in compliance with this Core Principle.
