Permitted F&O Collateral & Haircuts

The following table lists the Permitted Cover ICE Clear Europe Members may lodge to meet F&O Original Margin and other requirements (e.g. delivery margin and concentration charge etc). For the avoidance of doubt, Variation Margin must be paid in cash in the currency of the contract.

Please note that ICE Clear Europe will only accept USD denominated assets in respect of Original Margin requirements from FCM Clearing Members for 4d(a) Segregated Customer accounts.

Bonds accepted as Permitted Cover must be denominated in the domestic currency of the issuer.

Please also note that ICE Clear Europe applies restrictions to the Permitted Cover that can be lodged in respect of Futures & Options Guaranty Fund requirements. Full details can be found in section 14 of the Finance Procedures:
