LedgerX Fee Schedule

Fees for Weekly and Monthly Options

Trading is free for the Participant's first week on the platform. After that, the following fees apply.

- 1. For each transaction executed on LedgerX, each Participant to the transaction will be charged an execution fee that is equal to the lower of either (a) \$12.50 per contract or (b) 25% of the price per contract.
- 2. For each contract that results in settlement and delivery, the Participant exercising the option will be charged \$0.25 per contract that is exercised.

Fees for Day-Ahead Swaps

<u>Trading is free for the Participant's first week on the platform. After that, the following fees apply.</u>

1. For each transaction executed on LedgerX, each Participant to the transaction will be charged an execution fee that is equal to \$3.00 per contract.

Fees for Day-Ahead Options

<u>Trading is free for the Participant's first week on the platform. After that, the following fees apply.</u>

1. For each transaction executed on LedgerX, each Participant to the transaction will be charged an execution fee that is equal to the lower of either (a) \$5.00 per contract or (b) 25% of the price per contract.

General Fees

- 1. A USD withdrawal fee of \$10 will be charged to the Participant per USD withdrawal.
- 2. A BTC withdrawal fee of 0.005 BTC will be charged to the Participant per BTC withdrawal.
- 3. Per-transaction fees charged by swap data repositories will be charged to the Participant. Liquidity Providers approved by LedgerX to participate in LedgerX liquidity programs may be offered fee reductions as part of the program. No such programs are currently in place.
