Subject: Weekly Notification of Rule Amendments for the Week of 20 March 2017

Dear Mr Kirkpatrick:

Please accept this notification pursuant to CFTC regulation § 40.6(d) of the below-described changes to the LCH.Clearnet Limited ("LCH") London Deposit Rate ("LDR") effective from Friday, 13 January 2017.

The LDR is applicable to cash balances (excluding default fund) held on SwapClear and ForexClear services Clearing Member accounts.

The changes recommended by the LCH Spread Review Group were approved by the LCH CEO and are as follows:

CCY	Benchmark	Spread	Change / No Change	Period
EUR	EONIA	60.0bp	Change (from 55.0)	22 Mar 2017 - 20 Apr 2017
GBP	SONIA	21.0bp	No change	22 Mar 2017 - 20 Apr 2017
USD	FedFunds	25.0bp	Change (from 23.0)	22 Mar 2017 – 20 Apr 2017
CHF	TOIS	48.0bp	No Change	22 Mar 2017 - 20 Apr 2017

These changes were notified via circular to Clearing Members in advance of the effective date.
