On Monday, March 20, 2016, the Exchange made administrative amendments to the NYMEX Rule 588.H. ("Globex Non-Reviewable Trading Ranges") Table. Specifically, the Exchange: (1) created separate tabs for each asset class; (2) identified the appropriate designated contract market within each asset class; and (3) implemented administrative, non-substantive amendments to the description of the non-reviewable trading ranges which, in no manner, impact the economic value of the parameters.
