Eurex Clearing Circular 035/21 ETF derivatives: Introduction of new ETF and ETC options

1. Introduction

Effective **17 May 2021**, the following measures of Eurex Clearing AG will apply:

The amendments to the Price List of Eurex Clearing AG (Price List) regarding:

- the inclusion of two ETF options and three ETC options newly introduced at Eurex Deutschland,
- the harmonisation of transaction fees for ETC options and futures.

2. Required action

There is no action required for participation.

3. Details of the initiative

Effective 17 May 2021, the Price List will be amended in order to reflect the appropriate updates regarding:

- the inclusion of two ETF options and three ETC options newly introduced at Eurex Deutschland,
- the harmonisation of transaction fees for ETC options and futures.

The following provisions will be amended as outlined in the Attachment:

Numbers 3.1, 3.2.1.1, 3.3, 3.4, 3.7 and 3.9 of the Price List.

Any ordinary right of Eurex Clearing AG to terminate the respective contract (including a Clearing Agreement, if applicable) shall remain unaffected.

Unless the context requires otherwise, terms used and not otherwise defined in this circular shall have the meaning ascribed to them in the Clearing Conditions or FCM Clearing Conditions of Eurex Clearing AG, as applicable.
