ICAP Global Derivatives Limited ("IGDL") ("**Applicant**") has submitted to the Commodity Futures Trading Commission ("**Commission**") a rule certification in IGDL-2016-R-6 pursuant to CFTC Reg. 40.6 in order to certify its revised discount appendix to its fee schedule implementing a revised discount program (the "**Certification**").
