

## **Eurex Clearing Circular 047/18**

# Consolidated calculation of volume rebates in selected products for registered Multiple Clearing Relationships

#### Summary

Effective **2 July 2018**, the following measure of Eurex Clearing will come into effect:

 Introduction of consolidated calculation of volume rebates in Futures products, as defined in Number 3.2.2.2 of the Price List of Eurex Clearing AG for Clearing Members and Non-Clearing Members with Multiple Clearing relationships (MCRs).

This circular contains all information on the consolidated calculation of volume rebates in Futures products for Clearing Members and Non-Clearing Members with MCRs and the updated sections of the Price List of Eurex Clearing AG, which will come into effect on 2 July 2018.

# Consolidated calculation of volume rebates in selected products for registered Multiple Clearing Relationships

Multiple Clearing Relationships (MCRs) offer Non-Clearing Members or Clearing Members the possibility to enter into a Clearing Agreement with other Clearing Members for the clearing of Eurex Transactions. It is an optional service provided by Eurex Clearing AG.

Non-Clearing Members or Clearing Members with admitted Eurex Member IDs for the Multiple Clearing Relationships set-up may register for a consolidated calculation of volume rebates across their main Eurex Member ID and the respective Multiple Clearing Relationships Eurex Member IDs, pursuant to Number 3.2.2.1(4) of the Price List of Eurex Clearing AG.

This option is valid for Futures products only as defined in Number 3.2.2.2 of the Price List of Eurex Clearing AG.

#### 1. Registration Process

Pre-requisite for the consolidated calculation of volume rebates is the existence of the **admitted** Multiple Clearing Relationships setup. To register, a Non-Clearing Member or a Clearing Member has to submit the list of their Multiple Clearing Relationship Eurex Member IDs and a designated main Eurex Member ID to Group Client Key Account Management. The registration form "Volume Rebate for Multiple Clearing Relationships" is available on the Eurex Clearing website under the following link:

The consolidated calculation will be available from 2 July 2018 onwards.

The Clearing Members and Non-Clearing Members can only register for <u>or</u> revoke the consolidated volume rebate calculation effective at the beginning of each calendar month, provided that notice is given by sending this form at least ten (10) business days prior to the first business day of the relevant month. To initiate the consolidated calculation starting with the month of July 2018, Clearing Members and Non-Clearing Members need to submit the registration form by 18 June 2018 at the latest.

#### 2. Calculation Methodology

Once a Non-Clearing Member or Clearing Member has registered for the consolidated volume rebate calculation, the eligible volume of registered Eurex Member IDs will be summed up and the volume rebate calculation will be based on the consolidated volume.

#### 3. "Monthly Rebate Report" CB179

The "Monthly Rebate Report" CB179 contains the information about volume rebates per Eurex Member ID. In addition, a new field "membGrpIdCod" will be provided in the "Monthly Rebate Report" CB179, which indicates whether a consolidated volume rebate calculation has been applied. In case of a valid registration, this field will contain the registered main Eurex Member ID. The new field is only available in the XML version of this report. For the respective rebate models, please refer to Number 3.2.2 of the Price List of Eurex Clearing AG.

#### 3.2.2 Volume Rebates

#### 3.2.2.1 General Provisions

- (1) ECAG shall grant volume rebates on a monthly basis (i) on Eligible Transaction Fees pursuant to Number 3.2.2.1 Paragraph 2 if (ii) Eligible Volume pursuant to Paragraphs 3 to <u>78</u> in a specific product group in a given calendar month (iii) exceeds at least the Tier 1 thresholds as defined in Numbers 3.2.2.2 and 3.2.2.3 and (iv) all further requirements of this Section are met.
- (2) Transaction fees, which originate from the matching or the registration of derivatives transactions pursuant to Number 3.1 regarding Eligible Volume ("Eligible Transaction Fees") are eligible for volume rebates.
- (3) Market Making-Eligible Volume considers all transactions per Eurex Member ID of a Clearing Member, Non-Clearing Member or Registered Customer, which have been correctly booked on P-Accounts. For the avoidance of doubt, transactions in Alternative Contract Specifications (as defined in Number 3.2.1 of the Eurex Contract Specifications) shall also qualify as Eligible Volume, if the aforementioned requirements are met.
- (4) In deviation to Paragraph 3 Sentence 1, Eligible Volume shall also consider transactions independent from a single Eurex Member ID if a Non-Clearing Member or a Clearing Member assigns the clearing of Eurex Transactions (as defined in Chapter I Part 1 Number 1.1.2 Paragraph 1 of the Clearing Conditions of Eurex Clearing AG) to several Clearing Members pursuant to Chapter II Part 1 Number 1.9.1 of the Clearing Conditions of Eurex Clearing AG and if the respective Non-Clearing Member or Clearing Member registers for a consolidated calculation of volume rebates using his main Eurex Member ID and the respective Multiple Clearing Relationship Eurex Member IDs. The eligible volume of registered Eurex Member IDs will be summed up and the calculation of the volume rebates will be based on the consolidated volume. In order to register, the Non-Clearing Member or Clearing Member shall submit the list of their Multiple Clearing Relation Eurex Member IDs and a designated main Eurex Member ID. The consolidated calculation of volume rebates according to this paragraph applies only in relation to volume rebates in Futures granted pursuant to Number 3.2.2.2.



#### Volume Rebates for Multiple Clearing Relationships

Non-Clearing Members or Clearing Members with admitted Eurex Member IDs for the Multiple Clearing Relationship setup may register for a consolidated calculation of volume rebates across their main Eurex Member ID and the respective Multiple Clearing Relationship Eurex Member IDs pursuant to Number 3.2.2.1(4) of the Price List of Eurex Clearing AG. To register, a Non-Clearing Member or a Clearing Member has to submit the list of their Multiple Clearing Relationship Eurex Member IDs and a designated main Eurex Member ID. The consolidated calculation of volume rebates applies only in relation to volume rebates in Futures granted pursuant to Number 3.2.2.2 of the Price List of Eurex Clearing AG.

Please note that once this option has been chosen, the relevant volume of individual Eurex Member IDs will be summed up and the volume rebates calculation will be based on the consolidated volume. The field "membGrpIdCod" for the Main Eurex Member ID in the CB179 "Monthly Rebate Report" will indicate that the consolidated rebate calculation has been applied. Please refer to "XML Report Reference Manual" for detailed report description and to Number 3.2.2 of the Price List of Eurex Clearing AG for the respective rebate models.
