Pursuant to Section 5c(c) of the Commodity Exchange Act (the "Act") and Section 40.6(a) of the regulations of the Commodity Futures Trading Commission (the "Commission"), TW SEF hereby notifies the Commission that it has amended its Rules by the issuance of a Market Regulation Advisory Notice ("MRAN"). This MRAN was prepared in response to CFTC Letter 15-67 regarding straight through processing. Today's MRAN will become effective on June 20, 2016, no fewer than ten business days from the date of this submission.
