Eurex Clearing Circular 038/21 Amendments to the Price List of Eurex Clearing AG

1. Introduction

This circular contains information with respect to the service offering of Eurex Clearing AG (Eurex Clearing) and introduces amendments to the Price List of Eurex Clearing AG (Price List) regarding the following topics:

A. Amendments to the Price List with respect to the service fee policy for Prefunding Amounts relating to OTC FX Transactions and OTC XCCY Transactions

B. Editorial change to the Price List regarding the Eurex website link update in the rebate section

The amendments above will become effective on **1 July 2021**.

2. Required action

No specific actions are required by clients.

3. Details of the initiative

A. Amendments to the Price List with respect to the service fee policy for Prefunding Amounts relating to OTC FX Transactions and OTC XCCY Transactions

For Clearing Members holding an OTC Currency Clearing License, Eurex Clearing AG will not apply any service fee to Prefunding Amounts. Furthermore, due to product-specific processing, Eurex Clearing AG will calculate customer interest rates for Prefunding Amounts on the basis of interest earned through the placement of funds instead of predefined benchmark rates.

To reflect these amendments, the following provisions will be amended as outlined in Attachment 1:

B. Editorial change to the Price List regarding the Eurex website link update in the rebate section

The recent Eurex brand refresh has also resulted in changes in the navigation structure of the Eurex website. In particular, the file containing Liquidity Class product assignments is now published under the following path on the Eurex website www.eurex.com:

Unless the context requires otherwise, terms used and not otherwise defined in this circular shall have the meaning ascribed to them in the Clearing Conditions or FCM Clearing Conditions of Eurex Clearing AG, as applicable.
