Weekly Notification of Rule Amendments

- 1 Singapore Exchange Derivatives Clearing Limited, a derivatives clearing organisation registered with the Commodity Futures Trading Commission (the “**Commission**”), hereby submits a notification of the following rule/editorial amendments made during the week of 2 July 2018:
 - (a) DC/AM – 37 of 2018: Margins for New SGX MSCI Net Total Return Futures Contracts (4 July 2018);
 - (b) DC/AM – 38 of 2018: Margin Changes for SGX-DT and SGX AsiaClear OTC Commodity Contracts (4 July 2018);
 - (c) DC/CCM – 22 of 2018: Clearing Fee Schedule¹ (4 July 2018); and
 - (d) DC/OTCF – Clearing Member Handbook:
 - (i) Amend timing for ‘INR RBIB’ rate announcement from about 12.30 p.m. to about 1.30 p.m.; and
 - (ii) Amend ‘PHP PDSPEO’ to ‘PHP BAPPESO’.
