Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT") and New York Mercantile Exchange, Inc. ("NYMEX") (collectively, the "Exchanges") certify to the Commodity Futures Trading Commission ("CFTC" or "Commission") administrative amendments to the CME, CBOT and NYMEX Rule 588.H. ("Globex Non-Reviewable Trading Ranges") table (the "Table") for certain energy, agriculture, equities, and weather futures and options contracts noted in Exhibit A below (the "Contracts") effective Tuesday, September 22, 2020.

The Exchanges are amending the Table to clarify and amend the language and values, and where appropriate remove anachronistic language and values, in the table to accurately reflect the Exchanges' non-reviewable trading range ("NRR") process as it pertains to the Contracts (collectively, the "Rule Amendments"). The Rule Amendments are administrative in nature will not alter in any way the trading characteristics or the economic value of the Contracts. The Rule Amendments are set forth in blackline format Exhibit A below. For convenience, a clean version of the Table in its entirety is also provided in Exhibit B under separate cover.

The Exchanges reviewed the designated contracts market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act") and identified that the Rule Amendments may have some bearing on the following Core Principles:

- Compliance with the Rules: The Exchanges shall continue its normal practice to establish, monitor, and enforce compliance with the rules of the contract markets for the Contracts, including the terms and conditions of the Contracts' amendments for CME Globex non-reviewable trading ranges.
- <u>Prevention of Market Disruption</u>: The Rule Amendments will not impede the Exchanges' capacity
 and responsibility to prevent manipulation, price distortion, and disruptions to these Contracts
 through currently established market surveillance, compliance, and enforcement practices and
 procedures.

- Availability of General Information: The Exchanges will amend the Rulebooks accordingly on the effective date, which is publicly available on the CME Group website, to reflect the changes that will be made to the rules pertaining to the NRRs of the Contracts.
- Execution of Transactions: The Rule Amendments will have no adverse impact on the central limit order book for the Contracts. These changes will not impede the Exchanges' ability as designated contract markets to provide a competitive, open, and efficient market mechanism for executing transactions that protects the price discovery and physical deliverable processes of the Contracts.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.6(a), the Exchanges hereby certify that Rule Amendments to the Table comply with the Act, including regulations under the Act. There were no substantive opposing views to the proposal.
