Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively, the "Exchanges") are notifying the Commodity Futures Trading Commission ("CFTC" or the "Commission") that they are self-certifying the adoption of new NYMEX/COMEX Chapter iv. ("Disclaimers") effective on September 19, 2018.

Specifically, the Exchanges are adopting Chapter iv. to streamline and house all of the Exchanges' Price Reporting Agency's ("PRA") required disclaimers in one single location. This will eliminate the need for required disclaimers to appear in the product chapter for affected products. The Exchanges will include a hyperlink in each relevant product chapter to Chapter iv. New NYMEX/COMEX Chapter iv. is provided in Exhibit A.

The Exchanges will commence this transition beginning with two (2) PRAs: Argus Media and S&P Global Platts. Upon the effective date of this submission, the Exchanges will commence replacing disclaimer rules from the relevant Argus Media and S&P Global Platts product chapters with hyperlinks to Chapter iv.

The Exchanges reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("Act") and identified that the adoption of Chapter iv. may have some bearing on the following Core Principle:

 Availability of General Information: The Exchanges will make Chapter iv. publicly available on CME Group's website.
