CONCISE EXPLANATION AND ANALYSIS OF THE OPERATION, PURPOSE, AND EFFECT OF THE PROPOSED RULE AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION’S REGULATIONS THEREUNDER

Eurex Clearing is amending the Clearing Conditions and Price List to reflect the decision of the Management Board of Eurex Deutschland and the Executive Board of Eurex Zürich to delist Daily Futures on TAIEX derivatives. Eurex Clearing offers clearing services for these contracts. To account for this delisting, amendments have been drafted to the Clearing Conditions and Price List.

Further information regarding the operation, purpose, and effect of the proposed amendments is discussed in the attached Eurex Clearing Circular 092/17, which is appended as Attachment A.

Eurex Clearing has identified the following derivatives clearing organization (“DCO”) Core Principle as potentially being relevant to the above amendments:

1. DCO Core Principle C (Participant and Product Eligibility): The amendments will comply with DCO Core Principle C because the amendments prepare for the delisting of a contract. All products listed on Eurex Deutschland and Eurex Zürich, and cleared by Eurex Clearing, will continue to be subject to appropriate standards in compliance with this Core Principle.
