EXHIBIT A

CBOT Rulebook Chapter 5 ("Trading Qualifications and Practices") (additions underlined)

524. TRADING AT SETTLEMENT ("TAS"), BASIS TRADE AT INDEX CLOSE ("BTIC") AND BASIS TRADE AT CASH OPEN ("TACO") TRANSACTIONS

The Exchange shall determine the products, contract months and time periods during which TAS, BTIC, and TACO transactions shall be permitted. Specific products, contract months and spreads eligible for pricing as TAS, BTIC, or TACO transactions are set forth in the TAS, BTIC and TACO Table ("Table") at the end of Chapter 5.
