Dear FOIA Compliance Staff:

Via the CFTC Portal, in a submission making non-substantive modifications to CFTC Submission Number 1609-2916-4032-85, dated today, October 5, 2016, ICE Clear US, Inc. ("ICUS") submitted a self-certification of amendments to the ICUS Default Management Procedures, pursuant to Section 5c(c)(1) of the Commodity Exchange Act and Commission Regulation 40.6(a). In conjunction with that submission, ICUS submitted confidential document, Exhibit A - ICUS Default Management Procedures (marked2). ICUS hereby respectfully requests Confidential Treatment under the Freedom of Information Act ("FOIA"), 5 USC Section 552 and pursuant to Commission Regulation 145.9 for all information included in, and attached to, this submission (the "Confidential Information") until further notice.

The Confidential Information contains confidential and non-public information of ICUS which is exempt from disclosure pursuant to Section 552(b)(4) of FOIA and Commission Regulation 145.9(d). The basis for the request is that disclosure of these document(s) would reveal confidential commercial and financial information of ICUS, the disclosure of which could have a material adverse effect on, and cause injury to, the operations and competitive position of ICUS. ICUS also requests that the Commission notify the undersigned immediately after receiving any FOIA request for such documents or any other court order, subpoena or summons for the same. Finally, ICUS requests that it be notified in the event the Commission intends to disclose such documents to Congress or to any other governmental agency or unit pursuant to Section 8 of the Commodity

Exchange Act, as amended (“CEA”). ICUS does not waive its notification rights under Section 8(f) of the CEA with respect to any subpoena or summons for such document(s).
