Re: Bloomberg SEF LLC – Rule Amendment and Related Request for Freedom of Information Act Confidential Treatment

Dear Ms. Knauff,

Pursuant to Section 5c(c) of the Commodity Exchange Act (the “Act”) and Section 40.6(a) of the regulations of the U.S. Commodity Futures Trading Commission (the “CFTC”, or the “Commission”), Bloomberg SEF LLC (“BSEF”), as the operator of a swap execution facility, hereby submits to the Commission a rule amendment (the “Amendment”).

We have submitted to the Assistant Secretary of the Commission for the Freedom of Information Act (“FOIA”), Privacy and Sunshine Acts Compliance a request that for reasons of business confidentiality, the Commission not disclose the Confidential Information (as defined below) or its contents in response to any FOIA request or otherwise for an indefinite period. We wish to inform you that the Confidential Information constitutes, *inter alia*, privileged and confidential trade secrets and commercial or financial information within the meaning of FOIA, 5 U.S.C. § 552(b)(4) and Part 145.9(d)(1)(ii) of the Commission’s regulations as well as confidential information covered by 18 U.S.C. § 1905.

For your reference, the Amendment set out on Annex A hereto is referred to herein as the “Confidential Information”.

Please promptly inform the following of any request for the Confidential Information or its contents made pursuant to FOIA or the Commission’s rules so that we may

substantiate the foregoing request for confidential treatment in accordance with Part 145.9 of the Commission's regulations.


