Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to extend the NYMEX Power Volume Incentive Program ("Program") through January 31, 2021. The extension of the Program will become effective on February 1, 2020. All other Program terms remain unchanged.

Exhibit 1 sets forth the terms of the Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The products included in this Program are listed for trading in the open and competitive market. Participants in the Program will be selected by NYMEX staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair, or abusive practices. All participants must execute a contractual agreement with NYMEX in which each participant will expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

NYMEX certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

# **EXHIBIT 1**

# **NYMEX Power Volume Incentive Program**

### Program Purpose

The purpose of the Program is to incentivize market participants to provide liquidity in NYMEX Power products on Globex or submitted for clearing through CME ClearPort. The resulting increase in liquidity benefits all participant segments in the market.

# Product Scope

All NYMEX North American Power futures and options that are traded on Globex or submitted for clearing through CME ClearPort ("Products").

## **Eligible Participants**

There is no limit to the number of participants that may participate in the Program. Participants may be NYMEX members or non-members.

#### Program Term

Start date is July 1, 2015. End date is January 31, 2020 January 31, 2021.

#### **Obligations**

Participants must meet certain volume thresholds, as determined by the Exchange, in order to receive the Program incentives.

#### **Incentives**

Upon meeting all obligations, as determined by the Exchange, Program participants may be eligible for predetermined incentives.

#### Monitoring and Termination of Status

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke Program participant status if it concludes from review that a Program participant has failed to meet the requirements of the Program.
