LedgerX LLC ("LedgerX") hereby submits to the Commodity Futures Trading Commission (the "Commission"), pursuant to Section 5c(c) of the Commodity Exchange Act (the "CEA") and Commission Regulation 40.6(d), this weekly notification following rule amendments made effective during the week of November 30, 2020. The attached Amendment became effective on December 2, 2020.

LedgerX's trading fees have been revised. The new fee schedule is attached hereto as <u>Appendix A</u>. A redline of the changes to the fee schedule are reflected in <u>Appendix B</u> attached hereto.

### LedgerX Fee Schedule

**Trading Fees** 

**Day-Ahead Bitcoin Minis Swap** Fees: \$0.05/contract. 1 contract = 0.01 BTC

**Bitcoin Mini Futures** Fees: \$0.05/contract. 1 contract = 0.01 BTC

**Bitcoin Mini Options** Fees: \$0.15/contract. 1 contract = 0.01 BTC

Please note, the fee can never be higher than 20% of the option premium per contract. If \$0.15 is more than 20% of the option premium per contract, the fee will be 20% of the option premium per contract.

### Withdrawal Fees

A USD withdrawal fee of .001 BTC will be charged to the Participant per BTC withdrawal

## LedgerX Fee Schedule

### **Trading Fees**

**Day-Ahead Bitcoin Minis Swap** Fees: \$0.05/contract. 1 contract = 0.01 BTC

**Bitcoin Mini Futures** Fees: \$0.05/contract. 1 contract = 0.01 BTC

**Bitcoin Mini Options** Fees: 0.150/contract. 1 contract = 0.01 BTC

Please note, the fee can never be higher than 20% of the option premium per contract. If \$0.10 is more than 20% of the option premium per contract, the fee will be 20% of the option premium per contract.

**Liquidity Maker Fee Model** 

#### Liquidity Makers (Providers) Executing in the Customer Limit Order Book

- A Liquidity Provider shall not be charged trading fees for trades executed in the Customer Limit-Order Book
- Liquidity Takers will pay fees in accordance with the LedgerX Fee Schedule (above)

#### Withdrawal Fees

A USD withdrawal fee of .001 BTC will be charged to the Participant per BTC withdrawal
