New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the Oil Options Liquidity Provider Program ("Program"). The modifications to the Program will become effective on February 1, 2024.

Exhibit 1 sets forth the terms of the Program. Modifications appear below, with additions <u>underlined</u> and deletions <del>overstruck</del>.

The Exchange reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, NYMEX staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, Availability of General Information, and Recordkeeping.

The Program does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will monitor trading in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The products included in this Program are listed for trading in the open and competitive market. Participants in the Program will be selected by NYMEX staff using criteria as further stated in Exhibit 1. Chapter 4 of the NYMEX rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with NYMEX in which each participant will expressly agree to comply with and be subject to, applicable regulations and NYMEX rules. The Program is subject to the Exchange's record retention policies which comply with the CEA.

NYMEX certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

## **EXHIBIT 1**

# **NYMEX Oil Options Liquidity Provider Program**

#### **Program Purpose**

The purpose of this Program is to promote electronic volume and open interest in crude and refined options products. More liquid contracts on the central limit order book benefit all participants in the market.

#### **Product Scope**

All NYMEX crude and refined options products that are traded on Globex ("Products").

#### **Eligible Participants**

There is no limit to the number of participants in the Program. Participants may be NYMEX members or non-members.

#### **Program Term**

Start date is July 1, 2018. End date is January 31, 2024 January 31, 2025.

#### **Hours**

RTH, ATH, and ETH.

#### **Obligations**

Participants must quote two-sided markets at predetermined average bid/ask spreads and minimum quote sizes, respond to requests for quotes ("RFQs"), and/or meet certain volume thresholds in the applicable products in order to be eligible to receive the incentives.

#### **Incentives**

Upon meeting all obligations, as determined by the Exchange, participants will be eligible to receive predetermined incentives.

### **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant has failed to meet its obligations or no longer meets the eligibility the requirements of the Program.
