Re: Amendments to Transaction and Clearing Fees for ICE Futures U.S. RIN and RVO Futures and Option on Futures and Related Amendments
Submission Pursuant to Section 5c(c)(1) of the Act and Regulation 40.6(a)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(a), ICE Futures U.S., Inc. ("Exchange") self-certifies amendments to the transaction and clearing fees for the Exchange's renewable identification number ("RIN") and renewable volume obligation ("RVO") contracts. Currently, futures and option on futures with the product set have different fee structures. The amendments increase fees in each of the product sets to establish a consistent fee structure across the RIN and RVO product sets for both futures and option on futures. A summary of the amendments to the fee structure is provided as Exhibit A. All other aspects of the applicable product's terms and conditions remain unchanged.

The Exchange will make the amendments described herein effective on February 1, 2024, or no sooner than 10 business days after receipt of this submission by the Commission.

Certifications

The Exchange is not aware of any opposing views to the amendments and certifies that the amendments to the fee structure for the products identified herein comply with the requirements of the Act and the rules and regulations promulgated thereunder. The Exchange has reviewed the designated contract market core principles ("Core Principles") as set forth in the Act and has determined that the amendments comply with the following relevant Core Principles:

COMPLIANCE WITH RULES

The fee structure applicable RIN and RVO futures and option on futures contracts are set forth on the Exchange's website. In addition, trading of the contracts continues to be subject to all relevant Exchange rules which are enforced by the Market Regulation Department.

AVAILABILITY OF GENERAL INFORMATION

The amended fees related to the applicable RIN and RVO futures and option on futures contracts will be available on the Exchange's website for public view, consistent with Regulation 38.400.

CONTRACTS NOT READILY SUBJECT TO MANIPULATION

The applicable RIN and RVO futures and option on futures are not readily subject to manipulation as they are based on established and liquid underlying cash markets. In addition, trading of the contract continues to be monitored by the Market Regulation Department.

FINANCIAL INTEGRITY OF CONTRACTS

The applicable RIN and RVO futures and option on futures contracts will continue to be cleared by ICE Clear Europe, a registered derivatives clearing organization subject to Commission regulation, and carried by registered futures commission merchants qualified to handle customer business.
