SUBJECT: **CME/CBOT/NYMEX/COMEX Exchange Transaction Fee Amendments Effective February 1, 2024**

(SER 9295R supersedes SER 9295 dated November 29, 2023 and is being issued to: (1) include the NYMEX EBO, MCE and SGO contracts to the list of products included in the transaction fee adjustment (page 10); (2) include the COMEX EDP contract to the transaction fee adjustment (page 14); and (3) correct the COMEX EDP contract non-member cash settlement fee (page 16). No other changes have been made to the original SER.)

Effective February 1, 2024, Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT"), New York Mercantile Exchange, Inc. ("NYMEX"), and Commodity Exchange, Inc. ("COMEX") will amend transaction fees as more specifically described in the tables below.
