Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to implement the FX Non-Roll Spreads Volume Incentive Program ("Program"). The proposed Program will become effective on July 1, 2023.

Exhibit 1 sets forth the terms of the Program.

CME reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, CME staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, Availability of General Information, and Recordkeeping.

The Program will not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. Exchange staff will monitor trading in the Program's products in order to prevent manipulative trading and market abuse. Additionally, the Exchange has implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The Program does not impact the Exchange's order execution. Participants in the Program will be selected by CME staff using criteria as set forth in Exhibit 1. Chapter 4 of the Exchange rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with CME in which each participant will expressly agree to comply with, and be subject to, applicable regulations and Exchange rules. Additionally, the Program is subject to the Exchange's record retention policies, which comply with the CEA.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

# **EXHIBIT 1**

# **FX Non-Roll Spreads Volume Incentive Program**

# **Program Purpose**

The purpose of this Program is to incentivize participants to enhance liquidity in the FX futures products listed below. The resulting increase in liquidity on the central limit order book benefits all participant segments in the market.

### **Product Scope**

All FX G5 futures non-roll spreads that are traded on the CME Globex Platform ("Products").

# **Eligible Participants**

There is no limit to the number of participants that may participate in the Program. Participants may be CME members or non-members. Participants cannot be concurrently enrolled in the FX Futures Spreads Member Bank Volume Incentive Program or FX Monthly Futures Market Maker Program.

## **Program Term**

Start date is July 1, 2023. End date is June 30, 2024.

## **Obligations**

Upon meeting certain volume thresholds in the Products, participants will be eligible to receive predetermined incentives.

# **Incentives**

Upon satisfying all obligations, as determined by the Exchange, participants will be eligible to receive incentives in the Products.

## **Monitoring and Termination of Status**

The Exchange shall monitor trading activity and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant has failed to meet its obligations or no longer meets the eligibility requirements of the Program.
