New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively the "Exchanges") are certifying to the Commodity Futures Trading Commission ("CFTC" or "Commission") amendments for the Daily Settlement Procedure Documents (the "Documents") certain metals futures contracts listed in Table 1. and Table 2. below (the "Contracts") effective on trade date August 30, 2023.

Specifically, the Exchanges will amend the Daily Settlement Procedure Documents for the contracts noted in Table 1. as follows:

• Gold (Enhanced Delivery) Futures

The settlement procedure for this contract is being established such that in addition to the outright liquidity of this contract, the daily settlement shall more closely rely on the liquidity of the Gold Futures (GC) contract as well as the inter commodity spread market between Gold Futures and Gold (Enhanced Delivery) Futures.

Micro Copper Futures Connect Financial Futures

Copper Financial Futures

Micro Platinum Futures

These contracts can be offset with their related core underlying futures contracts. Therefore, the settlement procedures for these contracts shall mirror the methodology currently utilized for such underlying futures contracts.

• U.S. Midwest Hot-Rolled Coil Steel (Platts) Futures U.S. Midwest Shredded Scrap (Platts) Futures

The daily settlement procedures for these contracts shall mirror the current methodology of similar metals contract.
