CONCISE EXPLANATION AND ANALYSIS OF THE OPERATION, PURPOSE, AND EFFECT OF THE PROPOSED RULE AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Eurex Clearing is amending the Clearing Conditions and Price List to reflect the launch of Great British pence (GBX) denominated Equity Total Return Futures (ETRFs) on Eurex Deutschland, as outlined in Eurex Clearing Circular 063/23, which is appended as Attachment A. Eurex Clearing will provide clearing services for these contracts. For avoidance of doubt, Eurex Clearing will clear these contracts outside the scope of its derivatives clearing organization ("DCO") license, which applies only to swaps.

Further information regarding the operation, purpose, and effect of the proposed amendments is discussed in Attachment A.

Eurex Clearing has identified the following DCO Core Principle as potentially being relevant to the above amendments:

1. DCO Core Principle C (Participant and Product Eligibility): The proposed amendments will comply with DCO Core Principle C because the amendments list new contracts, which Eurex Clearing clears outside the scope of its DCO license, and all products cleared by Eurex Clearing under its DCO license will continue to be subject to appropriate standards in compliance with this Core Principle.

Effective **6 November 2023**, Eurex Clearing AG will offer clearing services for new GBp (GBX) denominated Equity Total Return Futures (ETRFs) introduced at Eurex Deutschland.

- Amendments to the Clearing Conditions of Eurex Clearing AG (Clearing Conditions) regarding the inclusion of GBp (GBX) denominated Equity Total Return Futures (ETRFs),
- Amendments to the Price List of Eurex Clearing AG (Price List) regarding the inclusion of GBp (GBX) denominated Equity Total Return Futures (ETRFs).

Please refer to Eurex Circular 083/23 for detailed trading-related information, including fee classification and the related amendments to the Rules and Regulations of Eurex Deutschland.

**Production start: 6 November 2023** 

#### 2. Required action

Participants interested to trade ETRF/BTRF will need to fill in and submit the "Application Form for Participation in Trading/Clearing of Basket Trades Functionality" for the assignment of the ETRF product capacity and entitlement to Basket Trades functionality. The form will be sent to the participants via their Key Account Managers.

No additional registration is required for the participants already active in trading ETRF/BTRF. However, it is recommended that the participants analyze the potential impact front-to-back of the above changes.

Eurex Clearing AG shall assess whether these comments prevent the published amendments from becoming effective taking into account the interests of Eurex Clearing AG and all contractual parties.

Unless the context requires otherwise, terms used and not otherwise defined in this circular shall have the meaning ascribed to them in the Clearing Conditions or FCM Clearing Conditions of Eurex Clearing AG, as applicable.
