**RE: Weekly Notification of Rule Amendments Pursuant to Regulation 40.6(d)**

Dear Secretary Kirkpatrick:

Pursuant to Commodity Exchange Act Section 5c and Commodity Futures Trading Commission Regulation 40.6(d), the Minneapolis Grain Exchange, LLC ("MGEX") submits this Weekly Notification of the following rule amendments made effective during the week of October 23, 2023:

- October 24, 2023 Memo to MGEX Clearing Members reminding them of the 7:30 a.m. CT Monday, October 30, 2023 deadline to report offsets of November 2023 SPIKES Volatility Index futures, and Hard Red Spring Wheat Index, Hard Red Winter Wheat Index, Soft Red Winter Wheat Index, National Corn Index and National Soybean Index futures and options, effective for the Friday, October 27, 2023 trade date.

Effective October 24, 2023, MGEX made the following non-substantive typographical corrections to the following Rules:

- General formatting updates throughout
- The "0" in Rule 435.00. was removed due to typographical error
- "estalishing" was corrected to "establishing" in Rule 1015.00.(3)(a).
- "permissable" was corrected to "permissible" in Rule 1015.00.(3)(b).
- Text for Rules 1016.00., 1017.00., 1018.00., 1019.00., and 1020.00. were moved to separate paragraphs and not on the same line as the rule heading
- "withcash" was corrected to "with cash" in Rule 1020.00.
- The reference to "Page 7031" in Rule 2036.00. was removed
- "ealewhere" was corrected to "elsewhere" in Rule 2060.00.
- "a" was corrected to "an" on the Response to Commission Complaint Form
- "dependant" was corrected to "dependent" in Rule 826.00.
- "heat" was corrected to "Wheat" in Rule 8006.00.
