Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission ("CFTC") Regulation 40.6(a), ICE Futures U.S., Inc. ("IFUS" or "Exchange") hereby submits by written certification, the terms of the new MSCI India Index NTR Futures Contract Incentive Program ("Program"), which are set forth in Exhibit A. The Exchange believes that the Program will incentivize new participants to trade the Exchange's MSCI India Index NTR futures contract.

The Exchange certifies that the new Program, which will become effective on December 4, 2023, complies with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder. In particular, the Program complies with Core Principle 4 (Monitoring of Trading), Core Principle 9 (Execution of Transactions) and Core Principle 12 (Protection of Market Participants). The Program does not impact order execution priority or otherwise give participants any execution preference or advantage. In addition, the Exchange's Market Regulation Department actively monitors for trading abuses using electronic exception reports and will take appropriate action against any participants engaging in market abuses.

The Exchange further certifies that, concurrent with this filing, a notice of pending certification was posted on the Exchange's website. EXHIBIT A

ICE Futures U.S.[®], Inc. MSCI India Index NTR Futures Contract Incentive Program

Program Purpose

The purpose of the Program is to incentivize participants to provide volume and increase liquidity in the Exchange's MSCI India Index NTR futures contract. This enhanced liquidity will benefit all participants in the marketplace.

Product Scope

MSCI India Index NTR Futures

Eligible Participants

IFUS may designate ten participants in the Program. In order to be considered for selection into the Program, potential participants must have maintained a sufficient monthly average volume in one or more MSCI Index futures contracts over the past six months at the time of application. Notwithstanding the foregoing the Exchange may add or subtract from the aforementioned criteria as it deems necessary.

Program Term

The Program term shall end on December 31, 2024.
