Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of November 13, 2023.

On November 15, 2023, the Exchange implemented administrative amendments to the CME Position Limit, Position Accountability and Reportable Level Table (the “Table”) to correct typographical errors relating to commodity codes of the Options on Live Cattle Futures Calendar Spreads – 4 month (Commodity Code: C0B) and 6 Month (Commodity Code C0C) (collectively, the “Contracts”). Specifically, the Exchange corrected the Table to display the correct commodity code in the Single Month Aggregate Into Ratio Leg (2) column for Options on Live Cattle Futures Calendar Spreads - 4 Month (Commodity Code: C0B) and Options on Live Cattle Futures Calendar Spreads - 6 Month (Commodity Code: C0C). Please note that these amendments are simply designed to correct typographical errors in commodity code references and that appropriate aggregation levels have been applied operationally. The amendments to the Table are provided under separate cover in Exhibit A.
