Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT"), New York Mercantile Exchange, Inc. ("NYMEX"), and Commodity Exchange, Inc. ("COMEX") (collectively, the "Exchanges") hereby notify the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to modify the APAC FCM Incentive Program ("Program"). The modifications to the Program will become effective on January 1, 2024.

Exhibit 1 sets forth the terms of this Program. Modifications appear below, with additions <u>underlined</u> and deletions overstruck.

The Exchanges reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA"). During the review, Exchange staff identified the following Core Principles as potentially being impacted: Monitoring of Trading, Execution of Transactions, Protection of Market Participants, Compliance with Rules, Availability of General Information, and Recordkeeping.

The Program does not impact the Exchanges' ability to perform their trade practice and market surveillance obligations under the CEA. The Exchanges' market regulation staff will monitor activity in the Program's products to prevent manipulative trading and market abuse. Additionally, the Exchanges have implemented systems to track Program participants' volume to ensure proper distribution of earned incentives. The Program does not affect the Exchanges' order execution. Participants in the Program will be selected by Exchanges' staff using criteria as set forth in Exhibit 1. Each of the Exchanges' respective rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. All participants must execute a contractual agreement with the Exchanges' in which each participant expressly agrees to comply with, and be subject to, applicable regulations and applicable rules. The Program is subject to the Exchanges' record retention policies which comply with the CEA.

The Exchanges certify that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

EXHIBIT 1

APAC FCM Incentive Program

Program Purpose

The purpose of the Program is to incentivize participants to educate their customers about the benefits of trading the Exchanges' products and centralized clearing, ultimately providing additional liquidity to the marketplace. A more liquid contract benefits all participants in the market.

Product Scope

All CME, CBOT, NYMEX, and COMEX products that are traded on the Globex Platform, excluding cryptocurrency and event contracts ("Products").

Eligible Participants

There is no limit to the number of firms that can participate in the Program. The Exchange may designate up to thirty-five (35) participants in the Program. All approved CME, CBOT, NYMEX, and COMEX FCMs with non-member retail volume in the APAC region may participate. Participants must complete the APAC FCM Incentive Program application to be eligible for the Program.

Program Term

Start date is October 6, 2016. End date is December 31, 2023 December 31, 2024.

<u>Hours</u>

N/A

Obligations

Once accepted into the Program, participants must participate in at least two (2) marketing-planning sessions with the Exchanges on an annual basis and perform marketing initiatives which highlight CME, CBOT, NYMEX, and/or COMEX Products, excluding cryptocurrency contracts.

Incentives

Upon meeting all eligibility requirements and obligations, as determined by the Exchanges, participants may be eligible to receive predetermined incentives.

Monitoring and Termination of Status

The Exchanges' shall monitor activity in the Products and participants' performance and shall retain the right to revoke participant status if it concludes from review that a participant no longer meets the eligibility requirements or obligations of the Program.
