Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of December 28, 2020.

On December 31, 2020, the Exchange approved the application of Cedar Grove Warehouse, Inc. located in Buhl, ID to be designated as an Approved Warehouse for delivery of Spot Call Butter. The marketplace was alerted of the approval via MKR #12-31-20, which is attached hereto as Exhibit A.

Also, effective December 31, 2020, the Exchange approved the application of Sprinter Services, Inc.
