Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of January 3, 2022.

On January 4, 2022, the Exchange implemented administrative amendments to the NYMEX Position Limit, Position Accountability and Reportable Level Table (the "Table") to correct an omission from the <u>Appendix</u> provided in <u>NYMEX Submission 21-400</u> dated September 28, 2021.

Pursuant to NYMEX Submission 21-400, the Exchange certified amendments to the position limits aggregation for certain energy futures and options contracts to incorporate the CFTC position limit regulations and definitions of referenced contracts (the "Rule Amendments") to be concurrently effective with the CFTC regulations on trade date January 4, 2022. The administrative amendments implemented to the Table on January 4, 2022 are designed to correct the omissions from NYMEX Submission 21-400. A line item regarding the European Diesel 10ppm Barges FOB ARA (Platts) vs. NY Harbor ULSD Futures (Commodity Code EL1) (the "Contract") was inadvertently omitted from NYMEX Submission 21-400. In the Table, Ratio Leg (2) columns M, O, S, X, Z, AD, and AF will be corrected for the Contract. The Spot Month, Single Month and All Month Aggregate Into Ratio Leg (2) columns will be updated to accurately reflect the aggregation of the second leg of the Contract. There is no open interest in the Contract and therefore the appropriate aggregation levels have been applied and will continue to apply operationally.
