Dear Mr. Kirkpatrick:

Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions effective during the week of January 3, 2022.

On Friday, January 7, 2022, the Exchange implemented administrative amendments to the Strike Price Listing and Exercise Procedures Table (“The Table”) which provides information regarding strike price listing rules and exercise procedures including contrary instruction procedures for all CME and CBOT agricultural option contracts (the “Contracts”). The Table indicated contrary instructions are accepted “Until 5:30 p.m. CT on the business day following expiration day.” In practice and operationally, contrary instructions for the Contracts are accepted until 5:30 p.m. CT on expiration day. The Table has been corrected to delete language referencing the business day following expiration day as follows:
