Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of February 9, 2015.

On Tuesday, February 10, 2015, the Exchange made administrative amendments to the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations & Special Notices Section of Chapter 5 of the CBOT Rulebook to eliminate the "Intra Crop Year Spread Allowance" column as it is no longer applicable to any of the listed contracts. The Exchange also inserted a "Daily Accountability Level" column and harmonized the column headers of the Table to render the columns consistent across CME, CBOT, and NYMEX Rulebooks. The marketplace was notified of these amendments via Market Surveillance Notice ("MSN") #02-04-15, which is attached hereto as Exhibit A.

**SUBJECT:** Administrative Amendments to the Chicago Mercantile Exchange Inc. Position Limit, Position Accountability and Reportable Level Table

Effective February 10, 2015, and pending all relevant CFTC regulatory review periods, the Chicago Mercantile Exchange Inc. (CME or Exchange) will implement revisions to the CME Position Limit, Position Accountability and Reportable Level Table located in the Interpretations & Special Notices Section of Chapter 5 of the CME Rulebook. The revisions, which are reflected in [Exhibit A](#) of CME Submission [#15-054](#), **do not** alter the terms and conditions, including spot, single or all month limits, accountability levels, or aggregation allocations of any listed contracts.

In addition, effective February 10, 2015, the New York Mercantile Exchange, Inc. (NYMEX) and the Board of Trade of the City of Chicago, Inc. (CBOT) will implement revisions to the Position Limit, Position Accountability and Reportable Level Tables located in the Interpretations & Special Notices Section of Chapter 5 of each of the NYMEX and CBOT Rulebooks to eliminate the "Intra Crop Year Spread Allowance" column as it is no longer applicable to any of the listed contracts and insert a "Daily Accountability Level" column into, and harmonize column headers of, the CBOT Position Limit, Position Accountability and Reportable Level Table to render the columns consistent across CME, CBOT and NYMEX Rulebooks. The revisions are stylistic in nature and do not impact the terms and conditions of any listed contracts. The CFTC will be notified of the revisions during the week of February 16, 2015, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.
