On March 16, 2023, the Exchange implemented corrections to typographical errors in COMEX Submission No. <u>22-090</u> dated April 11, 2022. Specifically, <u>Appendix B</u> reflected erroneous values in the Settlement column of the NYMEX/COMEX Position Limit, Position Accountability, and Reportable Level table (the "Table"). The Settlement column for North European Hot-Rolled Coil Steel (Argus) Average Price Option (Commodity Code: EHO) contract should have been populated with Financially Settled Option instead of Financially Settled Futures. The amendments to the Table are provided under separate cover in Exhibit A.
